













FED ANNOUNCES FOURTH STRAIGHT 75 BPS HIKE

The Federal Reserve hiked rates by 75 basis points on November 2nd. Fed Chair Jerome Powell has since indicated that officials expect to increase rates by 50 bps at the December meeting.

INFLATION SLOWS MORE THAN FORECAST

The Consumer Price Index came in at 7.7% year-over-year in October, down from 8.2% in August and below economist expectations of 7.9%. Core CPI came in at 6.3% year-over-year, also below expectations.

MIDTERM ELECTIONS END WITH DIVIDED GOVERNMENT

Midterm elections didn't produce the red wave that many anticipated, with Republicans taking the House while Democrats are expected to maintain control in the Senate.

MAJOR CRYPTO EXCHANGE FILES FOR BANKRUPTCY


FTX.com, formerly the second largest cryptocurrency exchange in the world, filed for bankruptcy on November 11th. The ripple effects of this collapse have led consumers to question the solvency of other crypto firms.

BIG TECH BEGINS ANNOUNCING JOB CUTS

As financial conditions tighten and growth stagnates, even the largest tech companies have begun to batten down the hatches. Amazon announced plans to cut 10,000 jobs and Meta Platforms plans to cut more than 11,000.
